Welcome!



Welcome to Middle Temple Library's latest newsletter, which will be issued 3 times a year. At the moment the Library looks like a bit of a building site as the ground floor (formerly Refreshers and then La Grande Marque) is being transformed into a shiny new suite of offices for the Treasury, Education and Finance staff. It should be completed in a few more weeks and then we will have a new reception area and even better access to the library.

We have just produced a new copy of The Library Guide, which now includes an updated list of the areas of UK law in which each Inn specialises, and also an excellent guide to carrying out legal research, written by Master Woolley; both are available in the Library. Also, about to return from the printers, is an updated version of Library Resources for the Bar – a brief guide to the holdings of all four Inns' libraries.

Quit Rents

One thing I would like to tell you about is not really a library event but it is very interesting. The Rendering of the Quit Rents to the Crown takes place on Wednesday 12th October at 3.00pm. It is one of the oldest ceremonies in Britain, dating back to 1211, and involves the Exchequer Court sitting (in the Royal Courts of Justice) and paying the two quits of knives and horseshoes. It is performed by the Queen's Remembrancer, takes about 30 minutes, and is a fascinating step back in time. The Inn's involvement is giving the party safe passage from the Thames to the Court. Anyone can watch free from the public gallery.



New Electronic Content

Did you know that over 187 UK law journals are available in full-text format either through Westlaw or Lexis? Did you know that all of these titles are catalogued in our online catalogue, including those titles which are only available online? Of those titles which are only available online and not in hard copy, the catalogue record will specify 'available through Lexis / Westlaw only' and provide a link to our homepage. Both Westlaw and Lexis are accessible via our homepage. All of these titles are freely accessible in the Library, where articles can be printed or emailed. Unfortunately, our licence does not provide remote access [i.e. home or office use].

In addition, the Library now has online access to the *Building Law Reports, Equality Law Reports, Insurance & Reinsurance Law Reports,* and *The Law of Insurance Contracts.*

Equality Law Reports

The Library has recently subscribed to the Equality Law Reports both online and in hard copy. Launched in October 2010, Equality Law Reports covers case reports on all areas of employment discrimination, and nonemployment discrimination including access to goods, facilities and services, housing, education, and the public sector equality duty. There are important cases from the Employment Appeal Tribunal and other UK and European courts, with authoritative commentary and head notes by Michael Rubenstein on this fast-changing area of law, including how the Equality Act 2010 will be interpreted.

We shall have two e-books on a trial basis for two weeks, starting on October 3rd: Macdonald on *Immigration* and Laddie, Prescott and Vitoria on *The Modern Law of Copyright and Designs*. They will be loaded onto one of the OPACs in the Library. Feedback regarding the usefulness of e-books in the Library would be appreciated, and short surveys will be on hand.

We shall be serving tea and coffee at this free session, which is open to all members of the Inns of Court.

Chemistry in the Library

2011 has been declared The International Year of Chemistry – a worldwide celebration of the achievements of chemistry and its contributions to the well-being of humankind. One of the objectives is to celebrate the role of women in chemistry and the 100th anniversary of the Mme Curie Nobel Prize.

To mark the year, Middle Temple Library is currently exhibiting a selection of early works on alchemy and chemistry. 'Alchemy' and 'Chemistry' in the 17th century referred to the same discipline, and it was not until the 18th century that writers began to reserve the term alchemy for attempts to transmute base metals into gold. The display includes digital reproductions of illustrations from some books which are too fragile to be put on display.
