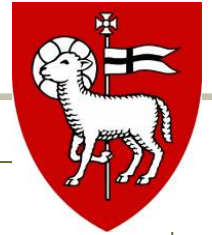

You will be pleased to know that we have taken out a subscription to Justis and Justcite which allows access to a number of law reports we do not take in hard copy including: Irish Case Law, Mental Health, Police, Prison, Inquest and Extradition Law Reports. Justcite searches across a wide range of case law, legislation, EU materials and journal articles. It then provides with each result: cases considered, subsequent cases, legislation considered, related legislation and articles. On the Lexis database, we now also have Halsbury's Laws online.

The collection of Prime Minister portraits is now complete, and every portrait has been labeled. We will be having an official unveiling in April. As the new year is now well under way, I should just give details of our Easter closing in March. 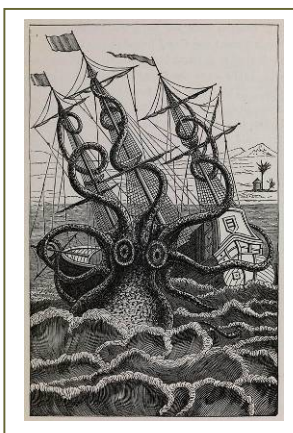
## New Evening Library Assistant

On 4 January 2013, the British and Irish Association of Law Librarians announced that the winner of their 2012 Dissertation Award was Erin Gow. While Erin is currently a Library Assistant at Gray's Inn, her paper "aimed to explore the information literacy and legal research training needs of users of the Middle Temple Library. It focused on the patterns of use of Library resources by users, reasons for these patterns, previous training users have received, and general evidence of user training needs in law libraries." Some of you may remember Erin's surveys dotted around the library, which members were asked to complete. These surveys were used to develop her dissertation. We would like to congratulate Erin on receiving this prestigious award.

## Early Journal Content on Jstor

In 2011 Jstor made its pre-1923 American and pre-1870 international content freely available to everyone. This covers close to 500,000 articles in over 200 journals. Users must register, and material is read online only (i.e. it can't be downloaded or printed).

Jstor is an archive of mostly academic journal titles. As such it does not cover current legal publications, and of those that are included, most are American titles. It will be mainly of interest to those engaged in historical research. Some legal titles included are: *Harvard Law Review*, *The American Law Register*, *Yale Law Review*, and *The American Journal of International Law*.

## Library Exhibition

This month's exhibition in the library features some items from the London Collection, chiefly maps and illustrations of some of London's historic past.

The London Collection contains over 200 items covering the history of London. It includes Stow's *Survey of London, Round and about London by Tram*, and a work about Brunel's Thames tunnel. Many of the items were presented to the Library in the 1940's by Guildhall Library. Presumably these were duplicate copies, and possibly Guildhall donated to the Inn to help re-stock the library after the war.
