Outreach

Very few people from working-class backgrounds ever consider becoming a barrister. Paul wanted this to change.

We aim to employ an Outreach Officer who will set up an Outreach Programme to enable students from non-traditional backgrounds to learn about the opportunities, threats, and challenges of becoming a barrister.

Scholarships

It is very expensive to train to become a barrister and the available financial support is limited. This means that those without financial means are discouraged from applying.

The demand for Middle Temple Scholarships is great. Unfortunately, this means that the Inn can only support a proportion of an applicant's funding shortfall. In 2018 this proportion was 55%. We hope that this Fund will enable the Inn to provide two 100% scholarships in the future to those applicants who need it most (subject to means testing).
