

I knew King John had visited Temple Church on a number of occasions, that William Marshal was his Chief Advisor and had ruled as Regent for the young Henry III, but I did not realise John had camped at the Temple for quite such a long period and regarded it as a sanctuary between 1214 and 1215 when he had two London headquarters of the Tower in the East and the Temple in the West, where he was protected by the Templars. I was also privileged to attend one of the performances of Shakespeare's "King John" in the Temple Church which was amazing and so atmospheric.

## RARE BOOKS COLLECTION

In April two early printed books were donated to the Library. One was a two volume set of the Letters of Junius, printed in 1799 and showing the signature of Sir Jonathan Frederick Pollack (1783-1870), a member of Middle and Inner Temples. The second donation was a copy of An Abstract of all the Penal Statutes printed by Christopher Barker in 1578. This edition is the third recorded copy in the UK of this work, which was compiled by Ferdinando Pulton (1536-1618), a member of Lincoln's Inn. This copy has some very interesting provenance history, belonging successively to Oliver Glanfeild (1572-1622), a rector in Devon, Everard Strangways Neave (1844-1896), a Lieutenant-Colonel in the service of the 18<sup>th</sup> Bengal Cavalry and John Cyril Maude (1901-1986), MP and Bencher of Middle Temple. It is bound in calf-covered wooden boards and is a fantastic addition to the rare books collection.

# GOVERNMENT PUBLICATIONS

#### Erin Gow, EU & Government Publications

You may have noticed an ongoing shift away from print and towards electronic production of Government and Parliamentary publications. These publishing changes mean that the way the Library collects and catalogues certain items is also changing. Most Government publications are now freely available online at:

as well as being available through a Library subscription to the Official Publications Online (OPO) database.

The Stationary Office (TSO), the primary publisher of official publications, is still producing print versions of some freely available electronic publications, but the way the print version is produced has changed. This means there is a lonaer gap between electronic and print publication for documents like Command Papers, and that not all documents are being produced in print. There are also now two different sets of information you can search for when looking for many official publications. Documents are issued in electronic format by Her Majesty's Government (HMG), and any documents that TSO publishes are assigned additional identifying information (such as an ISBN) unique to the TSO version.

While some documents such as Command Papers are still being produced in print format by TSO. other documents, such as most Government Departments' and Agencies' annual reports, are no longer being published in print. However, do keep in mind that the Library's subscription to the OPO database includes not only all recent documents produced by TSO, but also the HMG version of documents like annual reports that are no longer being produced directly by TSO. All documents found on OPO are also available for download as PDF, and can be printed, saved, or emailed for later access.

> Did you know that for a small fee the Library can supply copies of law reports, journal articles and textbook extracts by email, fax or post? We aim to provide a turn-around time of no longer than two hours and the majority of requests are completed within 60 minutes.

### 'POP-UP' RARE BOOK FAIR

On 23<sup>rd</sup> April the Library hosted a 'pop-up' book fair, with a portion of proceeds going towards UNESCO's literacy projects, as part of their World Book and Copyright Day. Fifteen antiquarian booksellers attended, exhibiting rare books covering a variety of subjects. More than 60 people attended. Some highlights exhibited at the fair included a variety of books on English cricket, a natural history of the hamster, first editions of the works of Ian Fleming, an early version of Beck's map of the London Underground and a book from the Kelmscott Press. # TOURS FOR JUNIOR CLERKS

As in 2013-2014, we again decided to organise tours for junior clerks this year. The main purpose of these tours is to help junior clerks to understand better how the Library works and what services we offer. One part of the tour is also focused on basic legal research. We strongly believe that this approximately 30-minute tour will provide junior clerks with a lot of useful information which should result in them becoming faster and more efficient when searching for a case or a specific publication. This year we welcomed around 25 junior clerks and administrative staff to the Library. Some of the clerks had been in the job for just a few days and found the tour very useful as an introduction to part of their future responsibilities. One pupil also took a tour. She had not been in the Library before the tour, but was sent here the following day and thanks to the tour she was able to find what she needed without almost any help. One interesting fact at the end - we noticed more female junior clerks than in previous years. A coincidence or a reflection of the real situation?

# LIBRARY USER SURVEY 2015

The survey was carried out via the Inn's website between December 2014 and March 2015. A link to the survey was emailed to Members in January and copies were also available for completion in the Library. 208 responses were received in total, including 10 from Members based overseas.

The most frequent requests were for extended opening hours, remote access to our online databases, and eBooks.
