# REMOTE ACCESS TO TWO NEW DATABASES

The Library is now able to provide remote access for free to two databases for 300 Middle Temple members. The first is Bloomsbury Professional Online, which provides access to 167 books and loose-leafs, including *Duckworth's Matrimonial Property and Finance, Employment Law and Pensions, The Law of Carriage of Goods by Sea and the Family Court Reports*. Starting in early February, the Library can also provide remote access for free to LexisPSL for 300 Middle Temple members. This offer only applies to those who do not already have an existing subscription to PSL, however. #### LIBRARY EXHIBITION: JOHN DONNE



John Donne (1572-1631) is chiefly known today as a poet and priest. At various times in his life he also served as a lawyer, diplomat, religious controversialist, Member for Parliament, and judge-delegate in the ecclesiastical courts. His intellectual interests reached into every branch of Renaissance knowledge, from divinity, law, history, languages, and statecraft, to medicine, geography, natural philosophy, botany, mathematics, and chemistry. Many of these interests, pursued by Donne in the books that he read, inevitably found their way into the books that he wrote, such as such The Courtier's Library, Biathanatos, Pseudo-Martyr, and Conclave Ignati. The various ways in which Donne's reading informed his writing is the subject of this exhibition.

The latest library exhibition features books from Donne's library acquired by the Library's founder, Robert Ashley (1565-1641) after Donne's death. The Library holds 84 titles that once belonged to Donne, the largest single holding of the 299 titles that survive of Donne's personal library.

These 84 titles reflect the character of Donne's library as a whole: the large majority concern various aspects of controversial divinity and moral theology, useful for Donne's work on *Biathanatos* and *Pseudo-Martyr*, a smaller portion in French focuses on law and politics; one work, in Spanish, deals with the legality of oaths and swearing. Other Latin texts concern natural philosophy, medicine, history and chronology. None of the titles are in English, and only very few might be considered 'literary' in the modern sense of the word.

Most of the books show clear evidence of Donne's ownership, and many also contain provenance and reading marks in Robert Ashley's hand. Some appear to have come to Donne from earlier owners, such as Ben Jonson or Charles Blount, Lord Mountjoy. Most of the books were rebound in the nineteenth-century, though one or two retain their original vellum or leather bindings.

The exhibition runs from January to the end of April 2018.
